The episode will be told by the Indigenous people and the responsibility of authenticity will be maintained.

#### Part 2: The Slain (90 min)

This installment unveils the grim reality of unsolved murder cases in Alaskan villages and beyond, including the challenges faced by those testifying. It delves into the lack of resources available to Indigenous people, such as emergency shelters and access to legal support, and the importance of educating Indigenous communities about their

rights and available resources. The episode also discusses how the changing climate and loss of traditional food sources exacerbate these problems, with the loss of cultural identity and stability contributing to the crisis. The episode will be told by the Indigenous people and the responsibility of authenticity will be maintained.

### Part 3: The Resilient (90 min)

The final episode emphasizes hope and resilience by highlighting the efforts of tribal organizations like the Tanana Chiefs Conference and individuals like Brittany Madros, working tirelessly to address the crisis. It explores topics like land rights, cultural preservation, food security, and climate change adaptation that directly impact Indigenous communities. This episode presents innovative ideas to make Indigenous people more difficult targets, such as visiting remote villages to fingerprint women and children, and promoting education on personal safety and legal rights. The episode showcases success stories, grassroots initiatives, and legislative efforts aimed at creating a safer future for Alaska's Indigenous people, along with the importance of restoring and maintaining a connection to the land, the river, and traditional foods. The docuseries concludes with a powerful call to action, urging viewers to support and contribute to the ongoing efforts to protect and empower Indigenous communities. The episode will be told by the Indigenous people and the responsibility of authenticity will be maintained.

Throughout the series, the focus remains on authenticity and presenting the stories from the perspective of the Indigenous communities affected. This docuseries aims to honor their voices and experiences, as well as inspire viewers to join in the fight for justice, safety, and the preservation of their rich cultural heritage.
